Violation: Approximately two hundred seventeen (217) citizen complaints that include allegations regarding the smell of the mausoleums, services and merchandise issues (e.g. upkeep of gravestones and mausoleum crypt plates, among other issues), and unmaintained cemetery grounds

Action: Provide a written response to all allegations describing its actions to resolve all meritorious complaints within seventy-five (75) days; failure to address and resolve citizen complaints may result in the opening of additional formal complaints. The cemetery company shall have an independent company to inspect mausoleums once monthly during the months of May, June, July, August, and September through 2020 and shall remediate all issues found within seven (7) business days. The Department may perform quarterly inspections in 2016 and 2017.
